The Colorado Department of Transportation's (CDOT) Division of Aeronautics is excited to announce that we are updating the Colorado Aviation Economic Impact Study (CEIS). This 2018 update will quantify aviation's economic contributions to our state and summarize the benefits our airports provide throughout Colorado.

We need your help to make this project a success! Because FBOs serve as a primary touchpoint for many airport users, your participation can greatly enhance the quality and quantity of data we receive for the CEIS. Our request is threefold:

- Complete the **FBO Survey**
- Distribute and encourage the completion of the General Aviation (GA) Transient
 Pilots/Passengers Survey

FBO Survey: All surveys are designed to obtain the information necessary to accurately calculate the economic impact of your airport. The FBO Survey contains questions regarding your staff and expenditures, as well as a comment area to share your insight into the unique

<u>GA Transient Pilots/Passengers Surveys:</u> A packet of hard copy surveys and a few signs requesting the participation of pilots and passengers are also enclosed with this letter. These surveys are intended to collect basic expenditure information from visiting passengers at your airport to help measure economic impacts of individual airports and the State's airport system. We kindly request that you post these signs in a highly visible area of your terminal/lounge area where airport users can complete the short (5-minute) survey. If possible, please direct potential participants to the surveys, as this will greatly assist in our efforts to measure the economic impact of Colorado airports.
